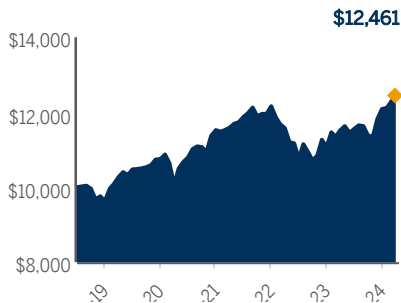

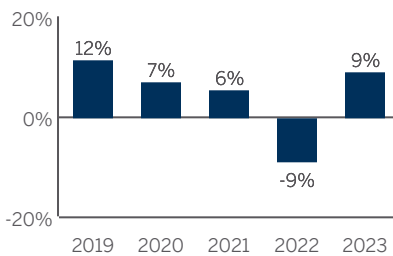

## PORTFOLIO CALENDAR YEAR RETURNS



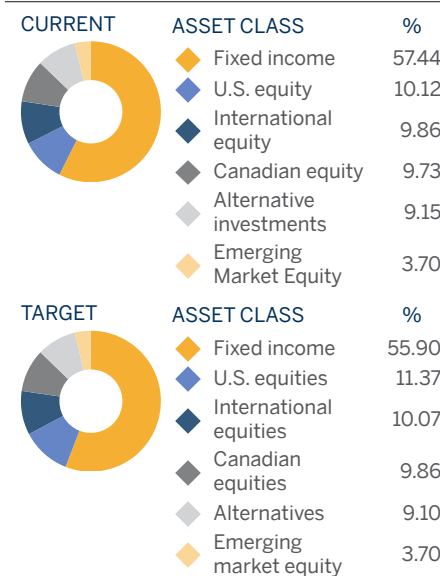
