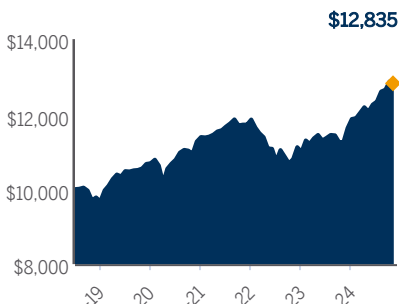

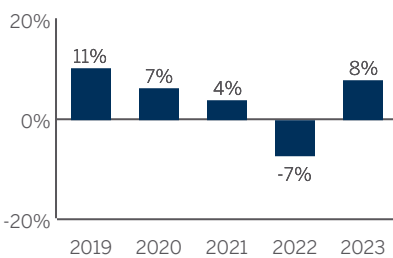
RISK RATING

PORTFOLIO CALENDAR YEAR RETURNS



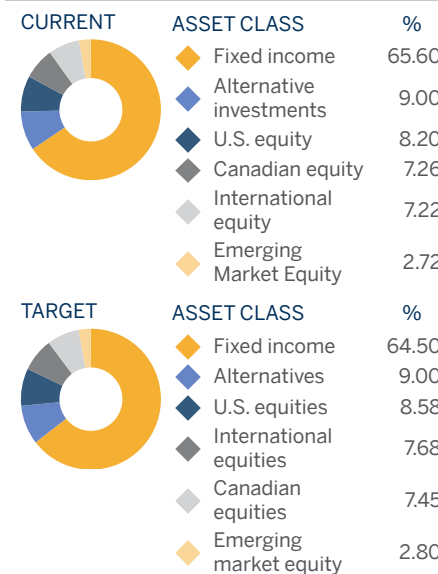
